

# The Bowral Market Guidelines

Second Saturday Monthly - 8 a.m. to 1 p.m.

## Bowral Bowling Club

The Bowral Market (TBM) is committed to providing quality Vendors with well attended markets operated in an atmosphere of safety, cooperation, and respect.

TBM is an outdoor market which operates in all weathers, the only exception being cancellation because of an extreme weather warning.

We do not provide gazebos, tables or chairs.

TBM is a non-smoking area.

### Bookings and Payment

- Confirmed attendees will receive their invoice approximately 10 days prior to the market date and must pay in a timely manner.
- TBM is an all-weather market - no credits or refunds are issued in the case of inclement weather.
- Power might be available at \$10.00 per market, per outlet.

### Market Day

- TBM operates from 8 a.m. to 1 p.m. – check in begins from 6:30 a.m. Please unload into your space, park vehicle as far away as possible from the venue, then set up your stall.
- Stalls must be contained within their assigned space and not encroach on other Vendors, or public pathways. A mark indicates the location of your pergola's right or left front upright, subject to your stall's orientation.
- Any operating licenses, permits and/or certificates must be available on market days.
- Vendors are responsible for properly securing pergolas against the elements.
- Children accompanying vendors must be supervised at all times.
- Vendors are responsible for the cleanliness of their stall area, must leave their space clean and remove all refuse from the market venue. Disposing of stall rubbish in on-site bins or skips is strictly prohibited.

## **Regulations, Terms & Conditions (RT&C)**

- Vendors are expected to treat each other and market goers with courtesy and respect.
- Site allocation is at the sole discretion of the TBM Organiser (TBMO). While we endeavour to allocate permanent Vendors a regular space, TBMO may move and reassign stall space at their discretion. No stallholder is guaranteed a site or the same site.
- Enquiries or comments concerning operations must only be directed to the TBMO.
- In accordance with Department of Fair Trading regulations the TBMO cannot offer exclusivity for any product(s). However, the TBMO do monitor duplication of offerings.
- TBMO retains the right to decline approval and/or refuse entry to any Vendor, product and/or service. And, reserves the right to reject an applications or rescind prior approval.
- TBMO retains the right to approve and/or restrict the goods and services Vendor's offer, or revoke/alter consent to sell goods or services. A Vendor's approval to operate can be revoked if the merchandise offered differs substantially from those approved.
- Stallholders must ensure that all structures erected at TBM are secured against strong winds, and that all equipment is positioned and operated in a safe manner. All stall content, including racks, tables, signage, etc. must be within the allocated stall space boundaries.
- Accepting an approval to operate at the TBM implies that the Vendor acknowledges that they understand and agree to comply with the RT&C. And, that the Vendor accepts that TBMO may alter any RT&C, and/or make additional RT&C.
- TBMO is not liable for any injury, theft, or damage to either the buyer or vendor, or their property, arising from or pertaining to preparation for or participation in the TBM, whether such injury, theft or damage occurred prior to, during or after TBM operating hours. Vendors further agree to indemnify and hold TBMO harmless for and against any claims for such injury, theft or damage.
